FTSE Russell (the trading name of FTSE International Limited and Frank Russell Company) confirms that IGM Financial has been independently assessed according to the FTSE4Good criteria, and has satisfied the requirements to become a constituent of the FTSE4Good Index Series.

Created by the global index provider FTSE Russell, the FTSE4Good Index Series is designed to measure the performance of companies demonstrating strong environmental, social and governance (ESG) practices. The FTSE4Good indices are used by a wide variety of market participants to create and assess responsible investment funds and other products.

IGM Financial was accepted into the index series following a rigorous independent assessment of the company based on a well-established methodology of key ESG themes. It recognizes IGM Financial's strong corporate performance in the areas of climate change, labour standards, human rights & community, social supply chain, corporate governance, risk management and anti-corruption.

"We are pleased to be identified by FTSE Russell as a company with holistic ESG practices and to be included in this globally recognized index," said Andrea Carlson, Vice-President, Finance and Corporate Responsibility. "The FTSE4Good Index facilitates investment in companies recognized for doing business in a responsible way."

IGM Financial is one of only three Canadian companies to have been accepted into the London-based FTSE4Good Index Series on June 20, 2016 as part of its semi-annual review. In total, only 25 Canadian companies have met the criteria to be included in this index, which is comprised of 824 companies globally.

The FTSE4Good designation is one of several recent achievements by IGM Financial in the area of corporate responsibility – a result, Carlson said, of enhanced reporting efforts and initiatives that demonstrate the company's longstanding commitment to sustainability.
