IGM FINANCIAL INC. ANNOUNCES JULY 2016 MUTUAL FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg –August 3, 2016: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total mutual fund net new money in July of (\$76.3) million as shown in Table 1. Total assets under management were \$138.5 billion at July 31, 2016, compared with \$134.7 billion at June 30, 2016 and \$137.9 billion at July 31, 2015. Mutual fund assets under management were \$132.3 billion as at July 31, 2016, compared with \$128.7 billion at June 30, 2016 and \$131.6 billion at July 31, 2015. Assets under management are shown in Table 2.
