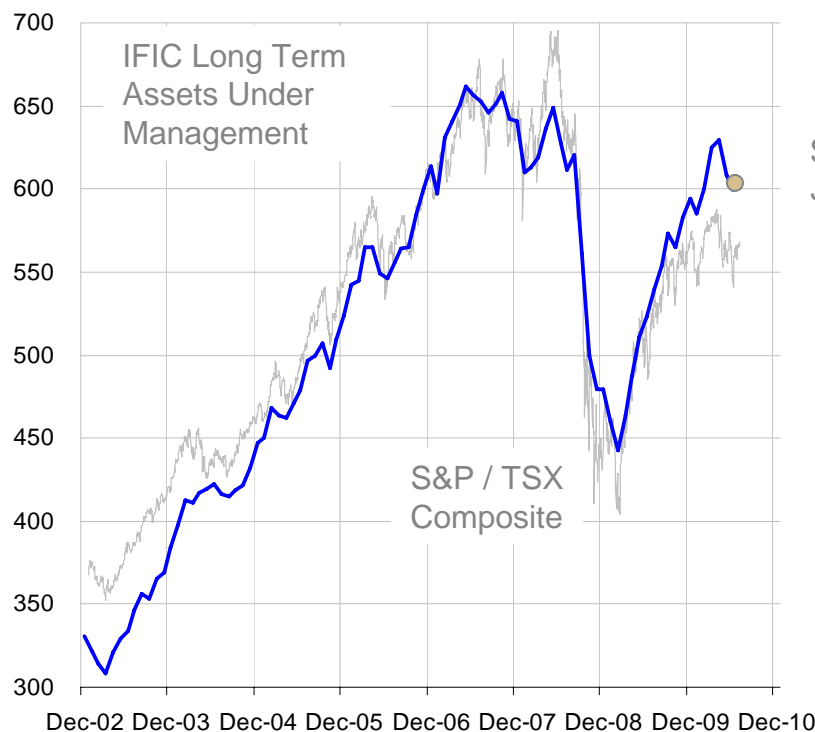

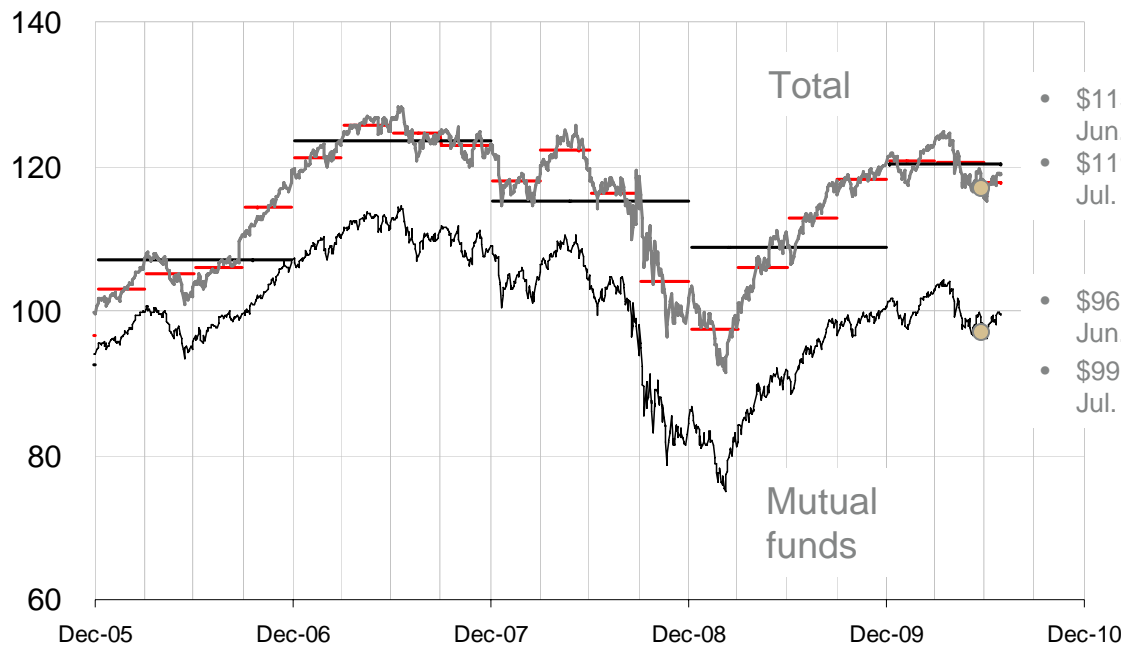

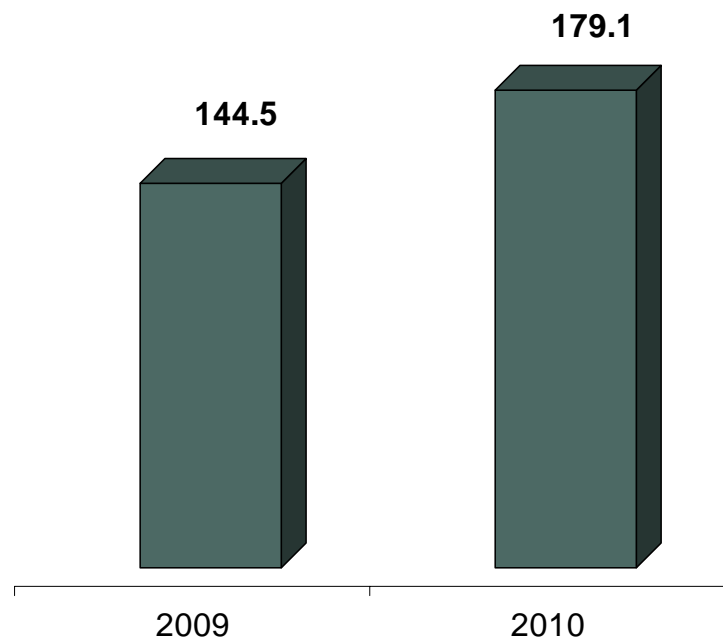

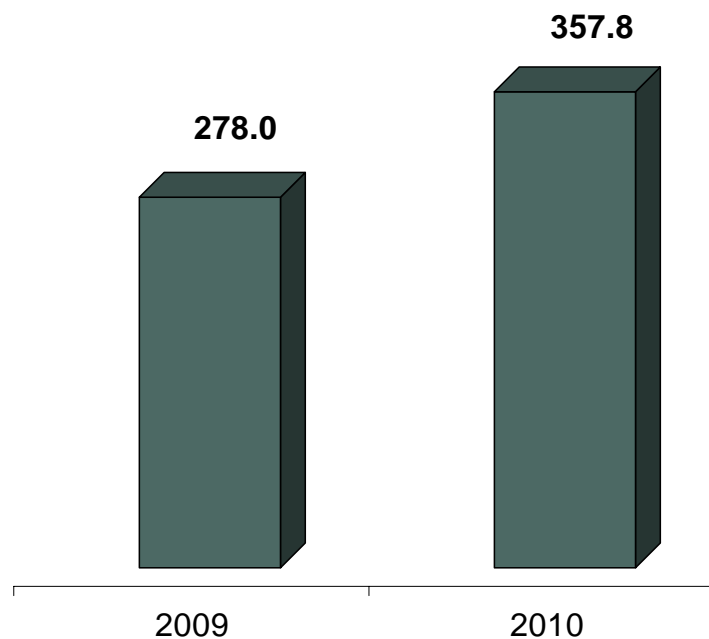

(\$ Millions)



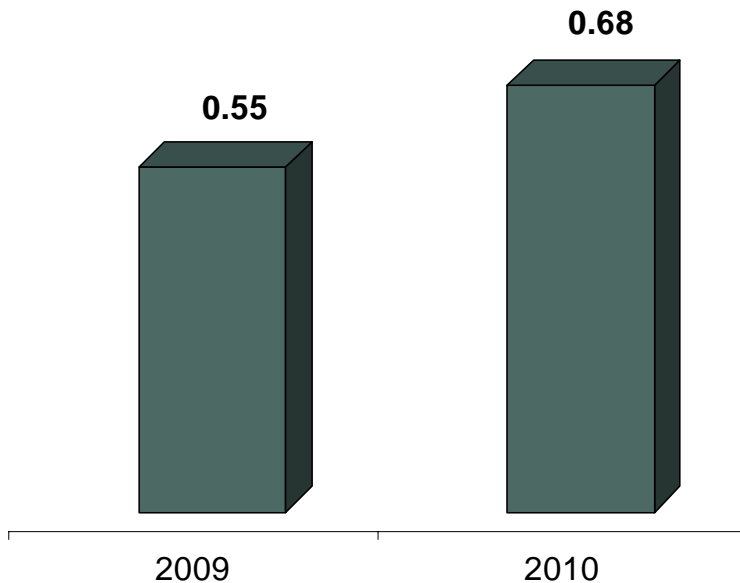
Net Earnings

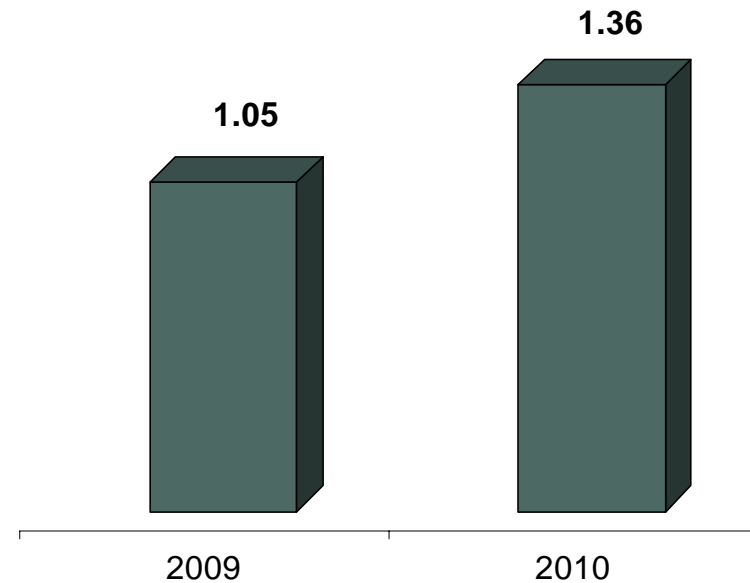

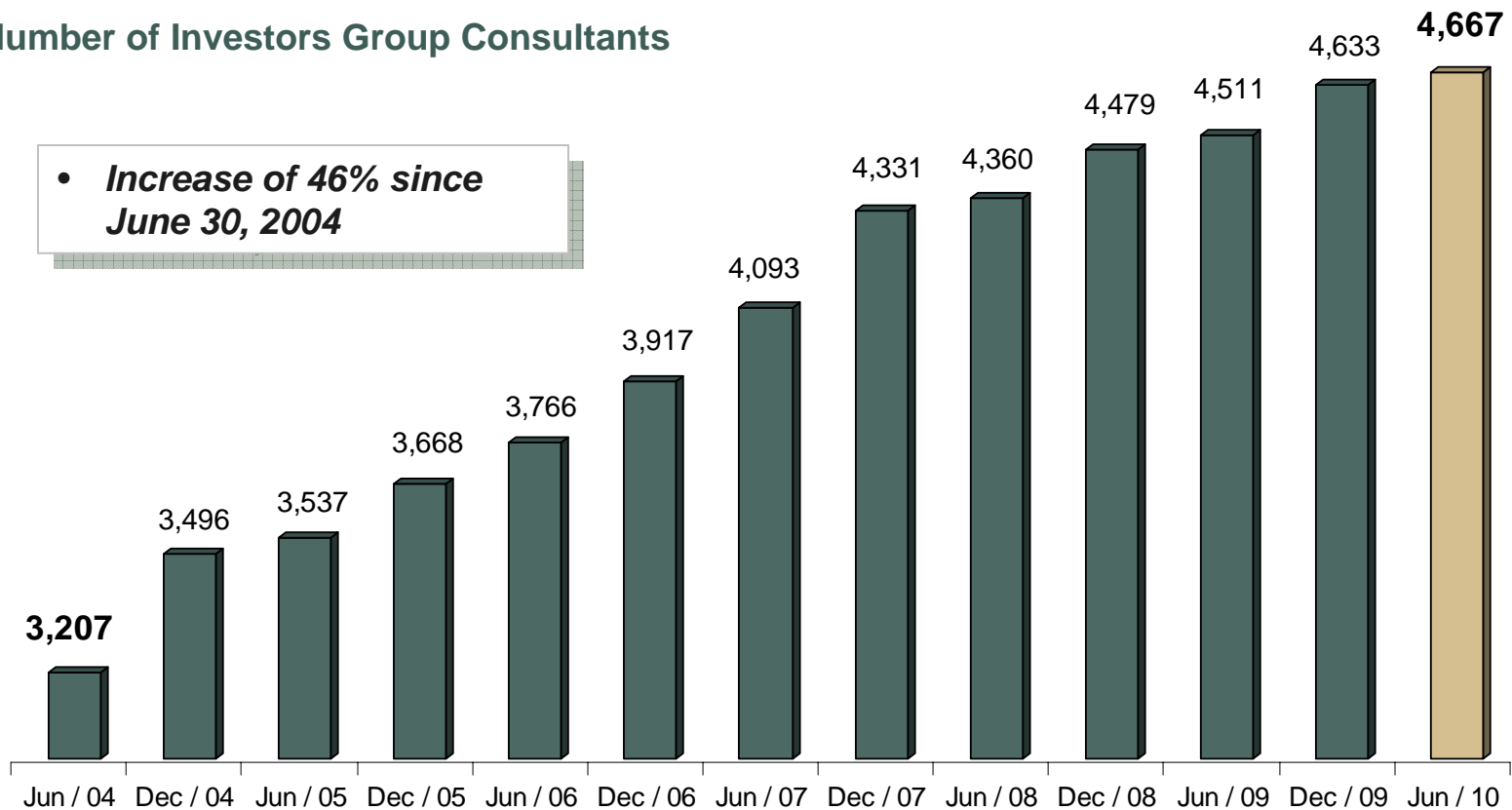

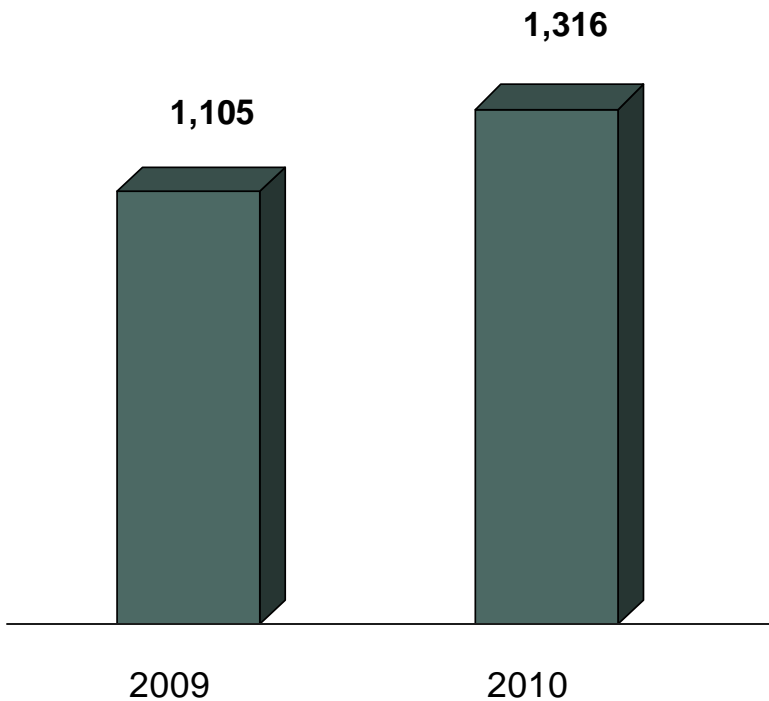
Number of Investors Group Consultants



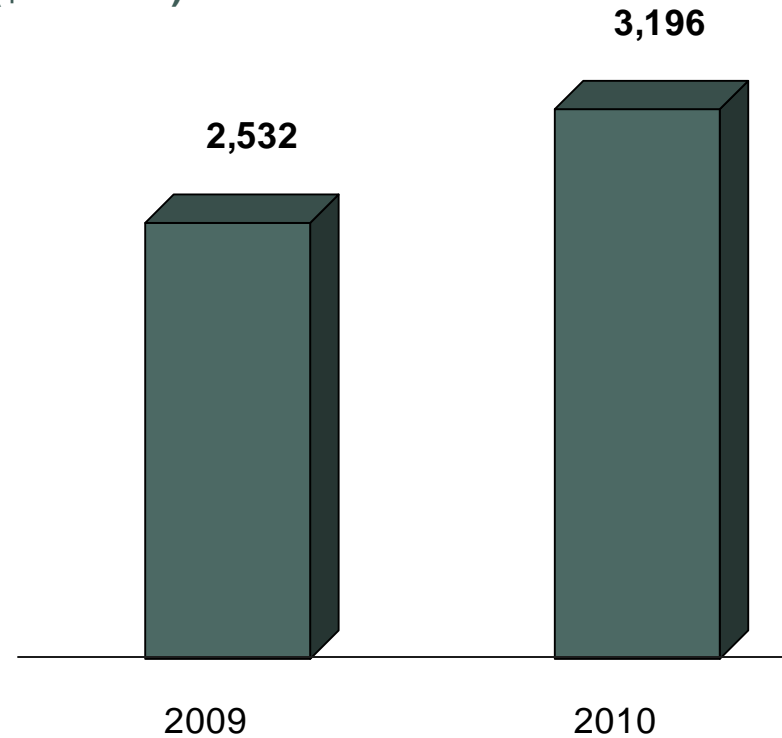

(\$ Millions)



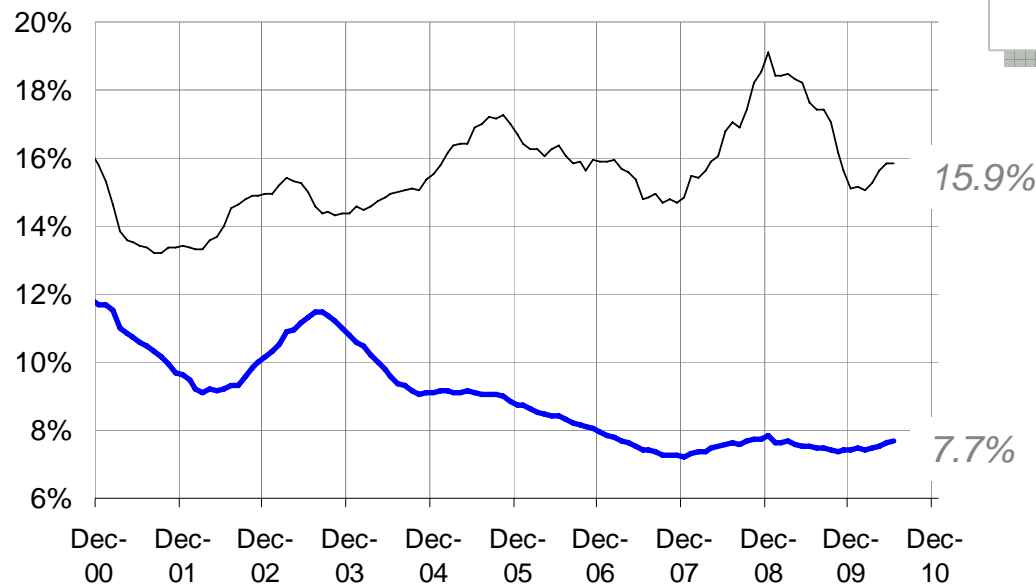
Mutual Fund Gross Sales

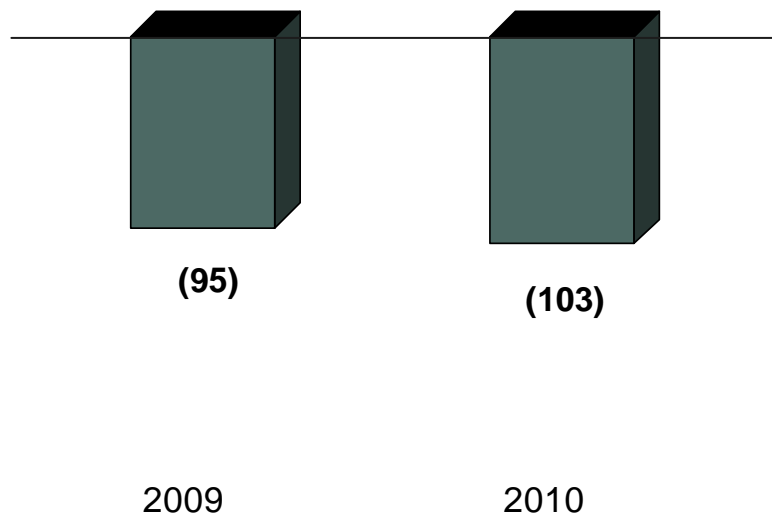

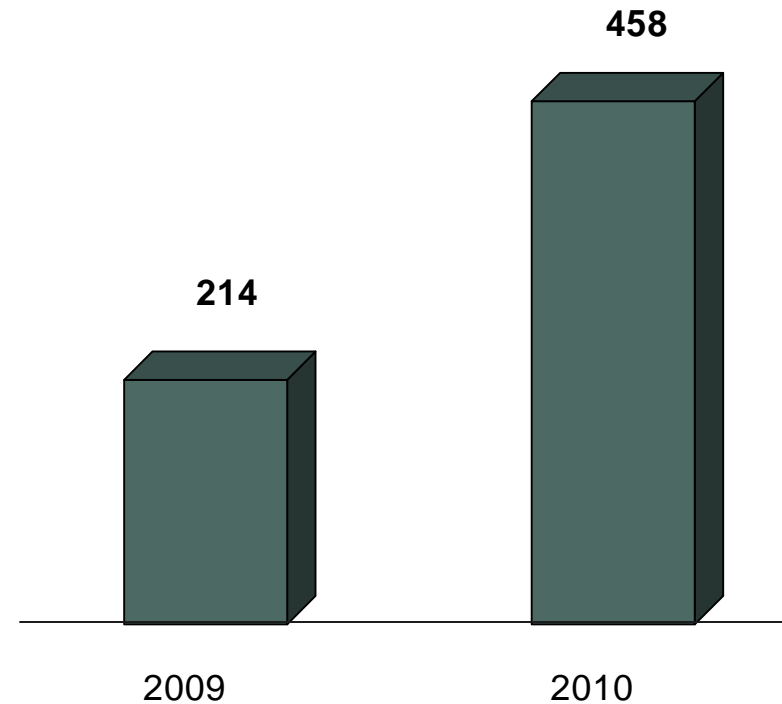
Investors Group Mutual Fund Net Sales

(\$ Millions)



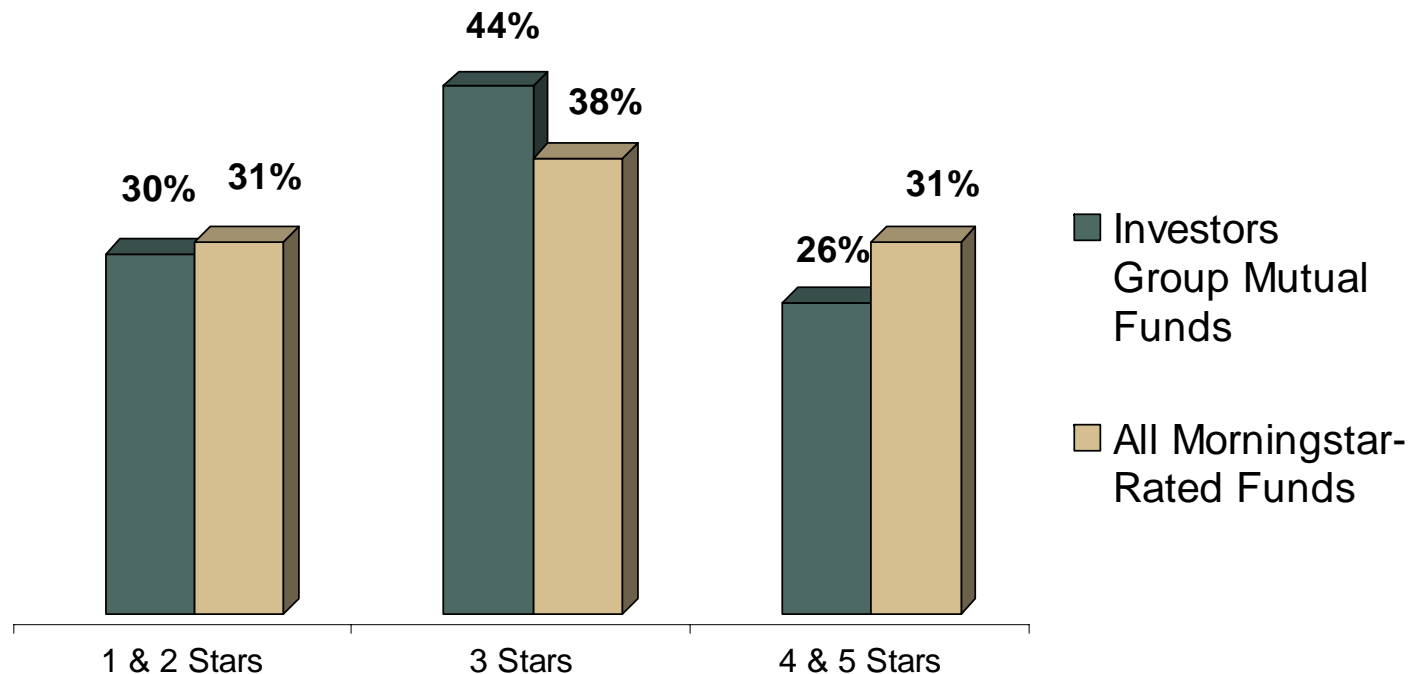
Mutual Fund Net Sales

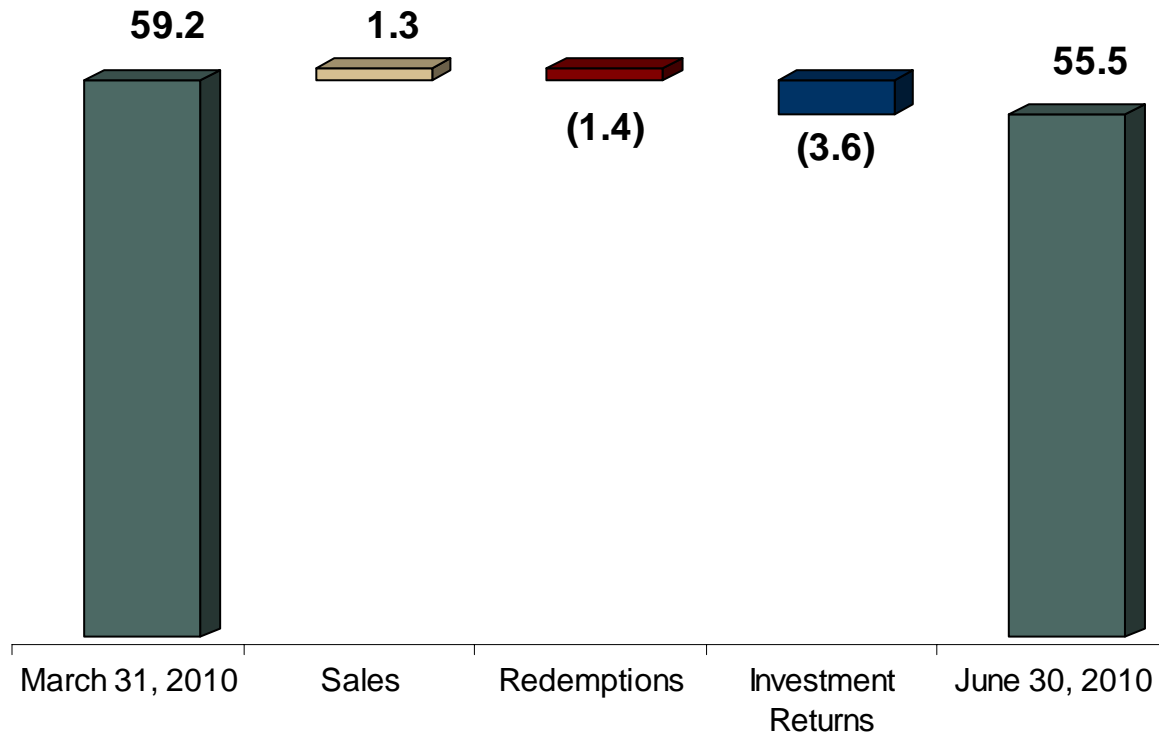
Morningstar Ratings as at June 30, 2010

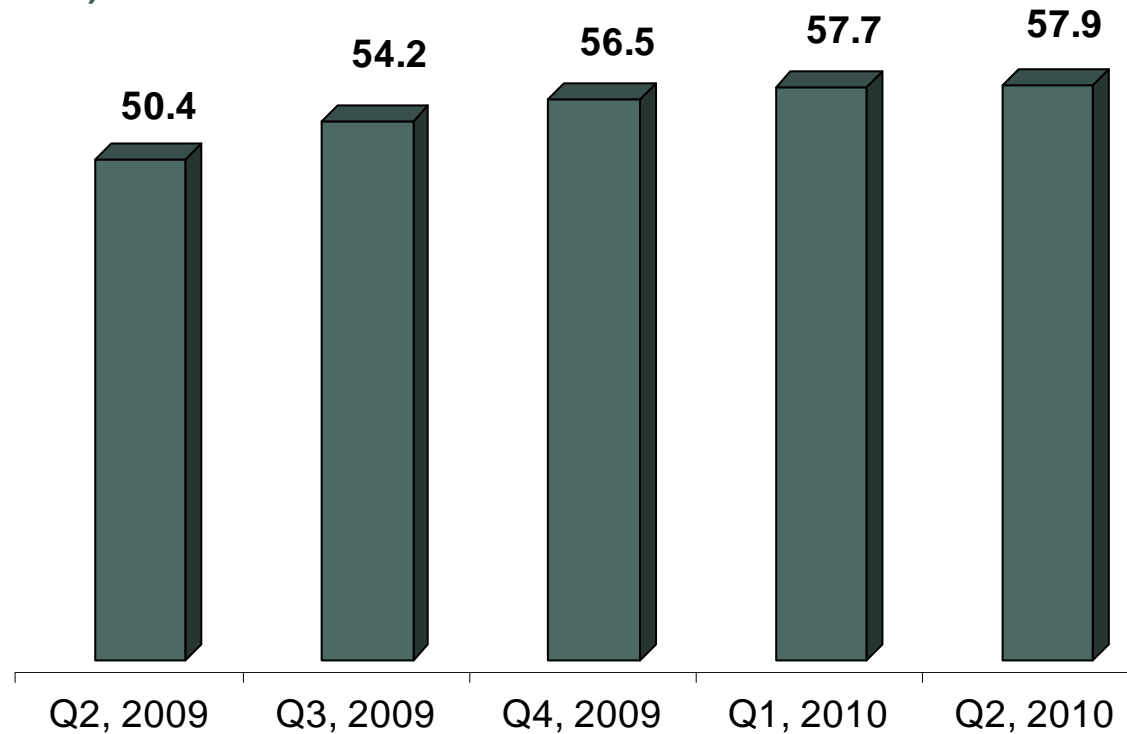
Change in Mutual Fund Assets Under Management

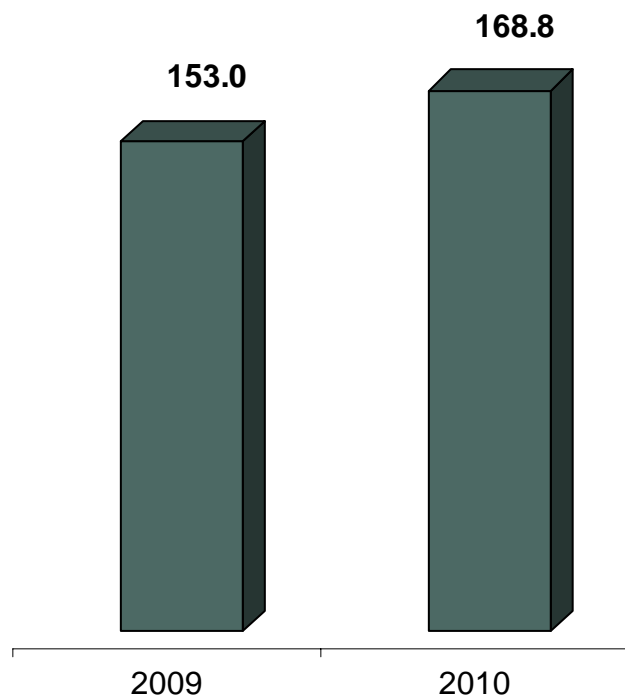
Average Mutual Fund Assets Under Management
(\$ Billions)



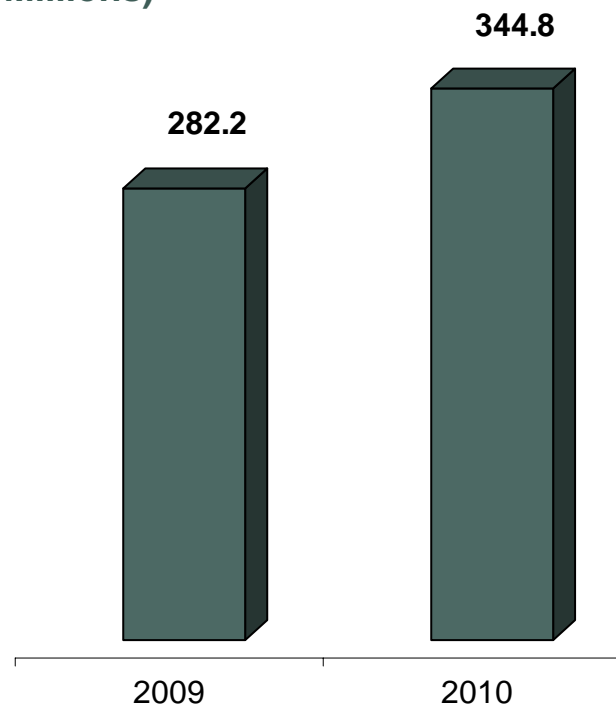

Investors Group Developments

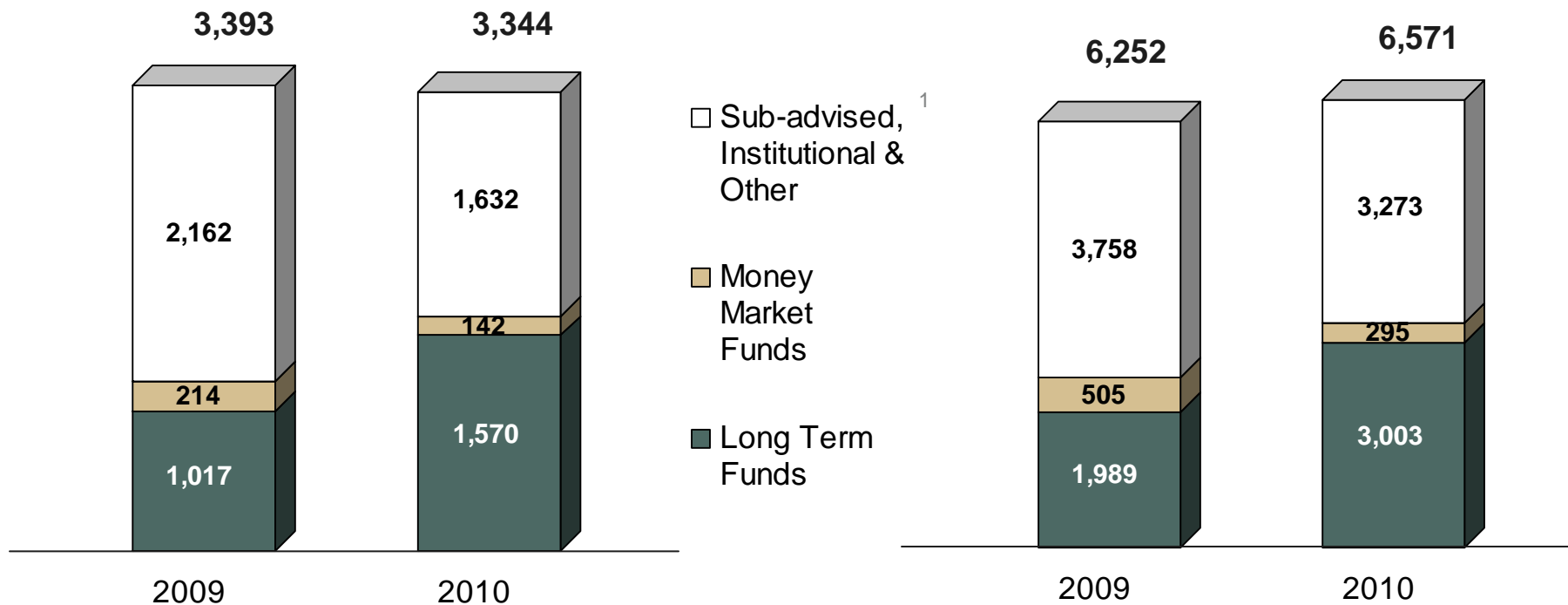

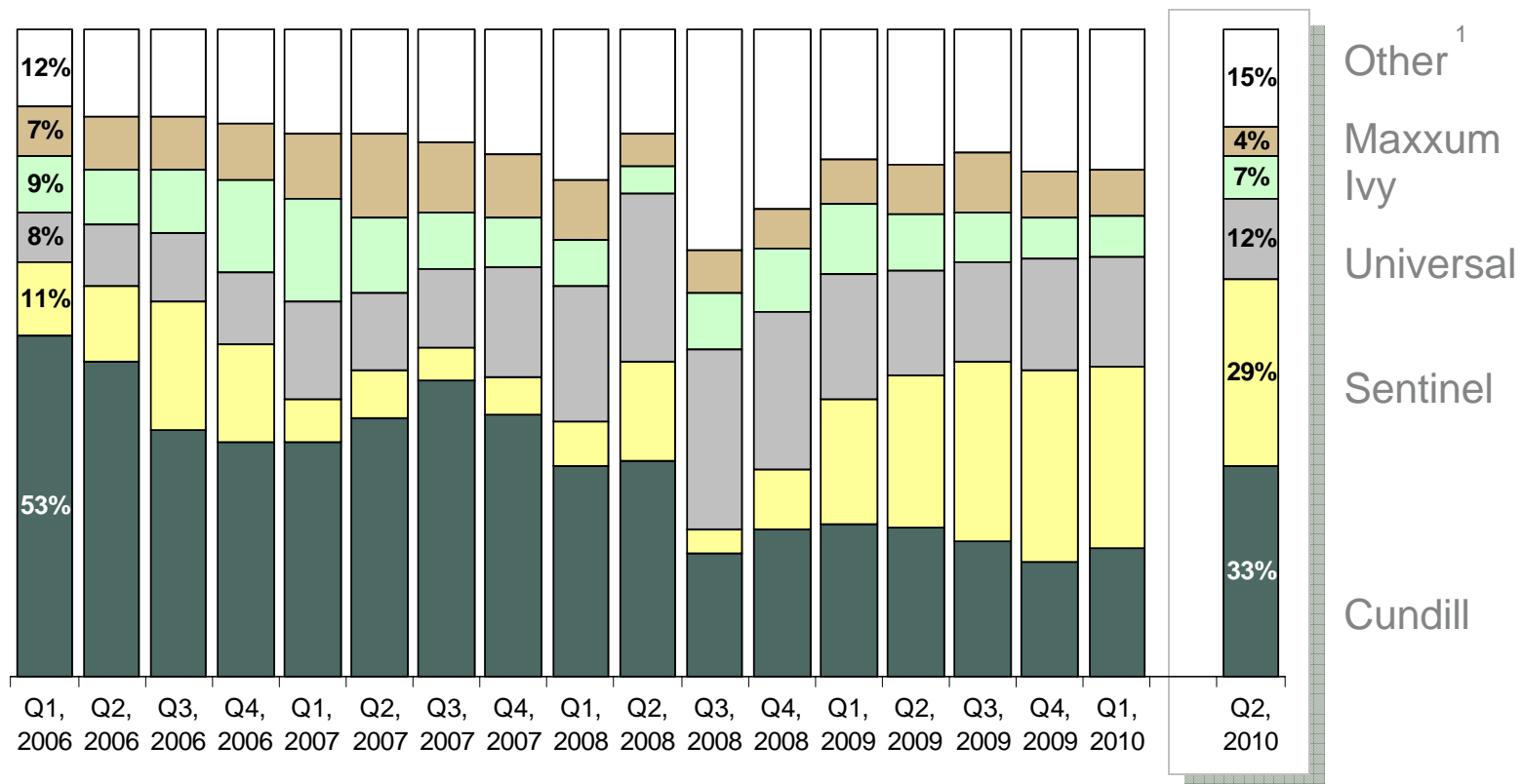

Gross Sales Mix of Long Term Mutual Funds by Mackenzie Sub-Brand

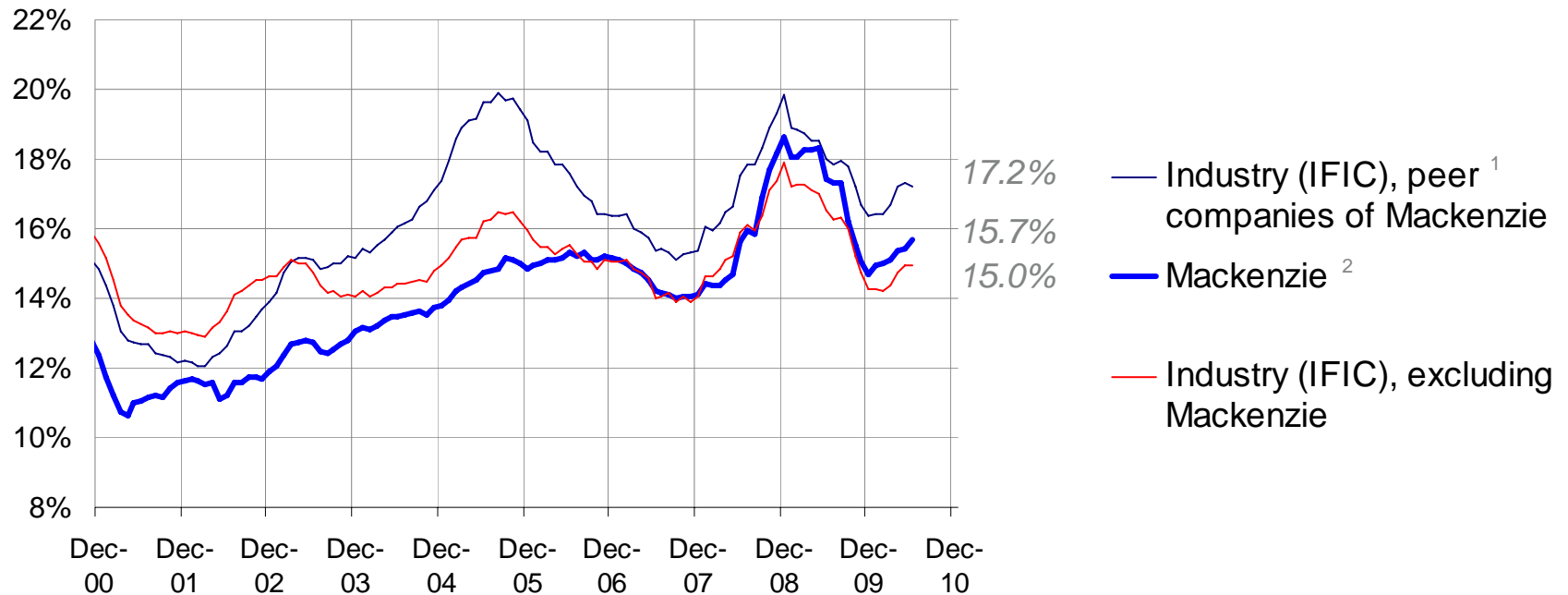

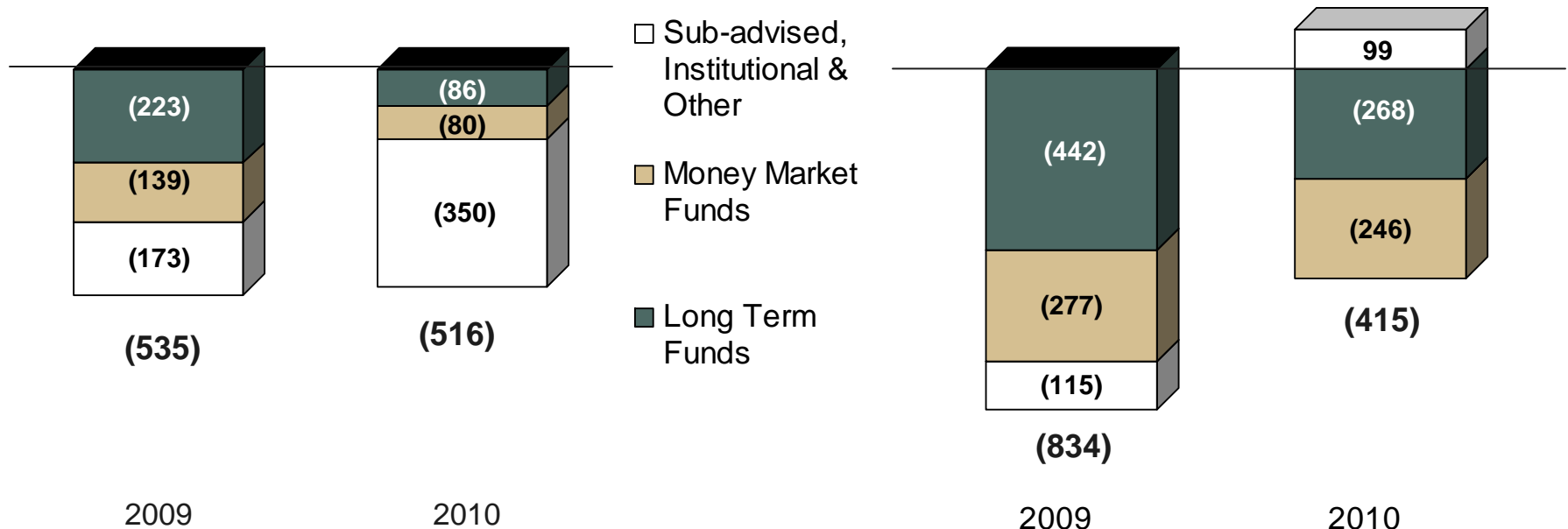

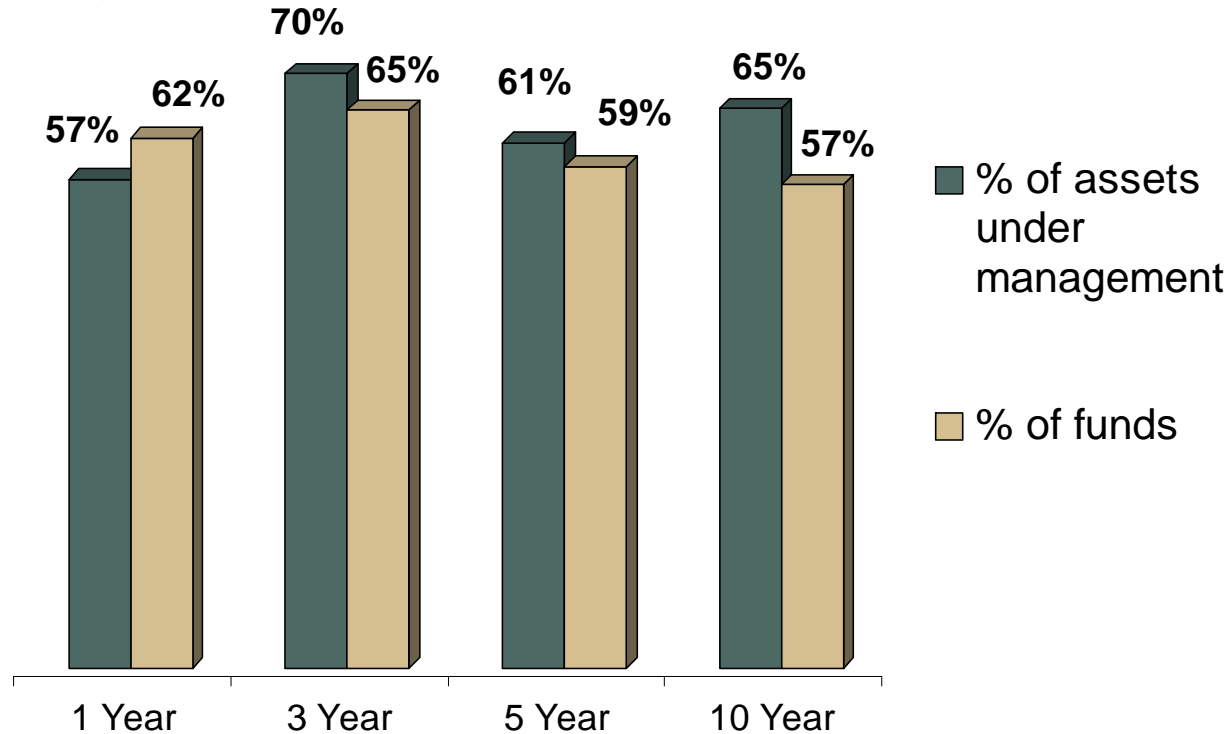

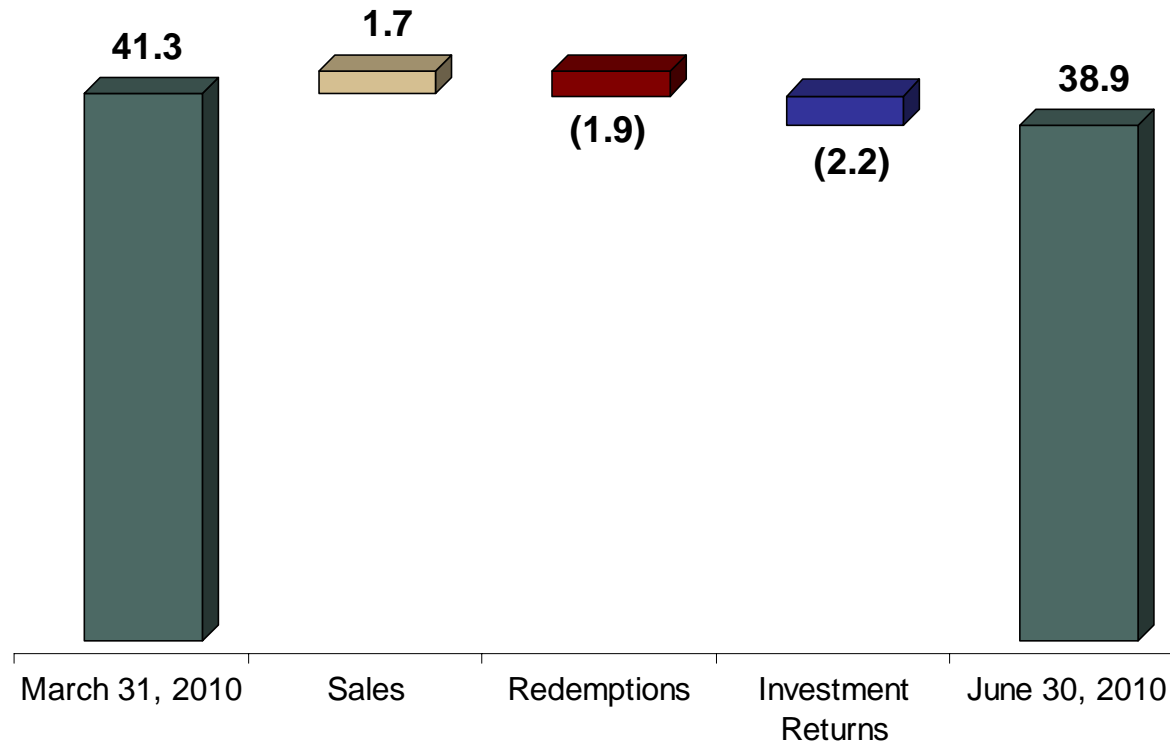
Mackenzie Mutual Funds in First or Second Quartile

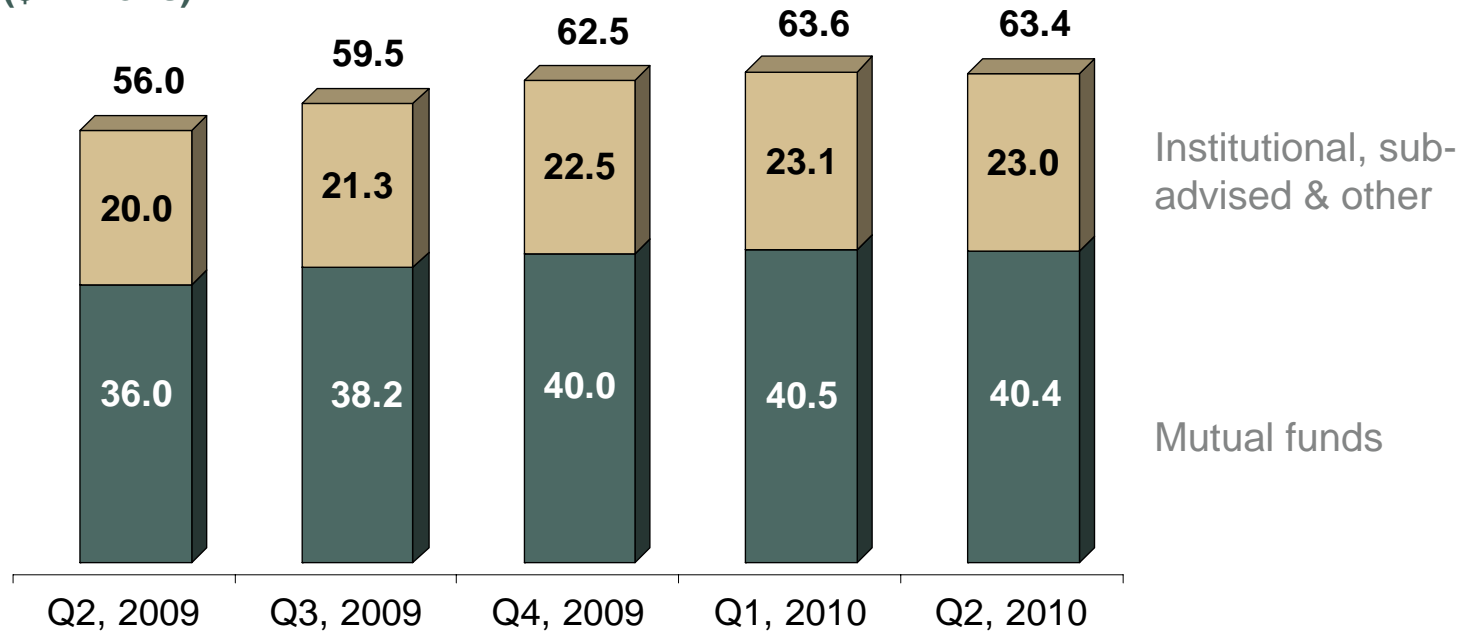
Mutual Fund Assets Under Management (\$ Billions)

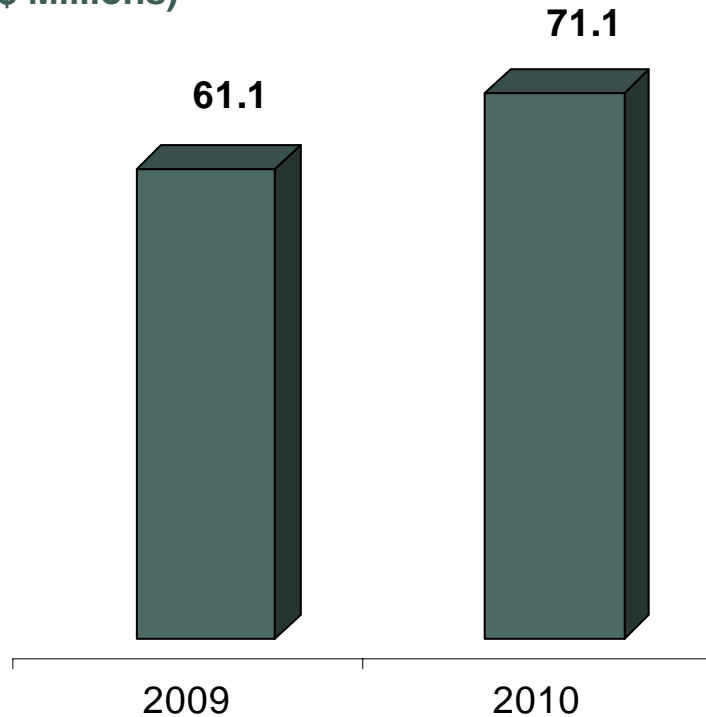
Mackenzie Average Assets Under Management
(\$ Billions)



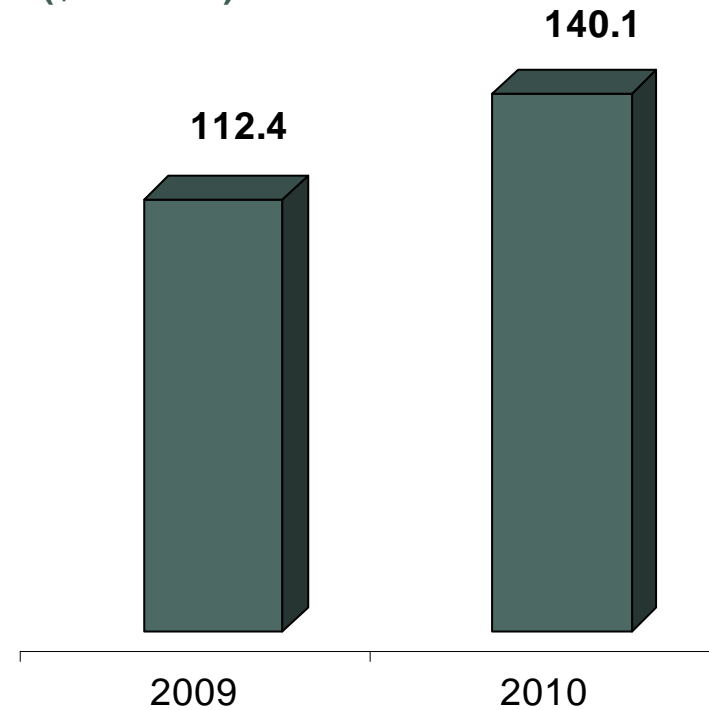
