About this report

The PRI Reporting Framework is a key step in the journey towards building a common language and industry standard for reporting responsible investment (RI) activities. This RI Transparency Report is one of the key outputs of this Framework. Its primary objective is to enable signatory transparency on RI activities and facilitate dialogue between investors and their clients, beneficiaries and other stakeholders. A copy of this report will be publicly disclosed for all reporting signatories on the [PRI website](#), ensuring accountability of the PRI Initiative and its signatories.

This report is an export of the individual Signatory organisation's response to the PRI during the 2020 reporting cycle. It includes their responses to mandatory indicators, as well as responses to voluntary indicators the signatory has agreed to make public. The information is presented exactly as it was reported. Where an indicator offers a response option that is multiple-choice, all options that were available to the signatory to select are presented in this report. Presenting the information exactly as reported is a result of signatory feedback which suggested the PRI not summarise the information. As a result, the reports can be extensive. However, to help easily locate information, there is a **Principles index** which highlights where the information can be found and summarises the indicators that signatories complete and disclose.

Understanding the Principles Index

The Principles Index summarises the response status for the individual indicators and modules and shows how these relate to the six [Principles for Responsible Investment](#). It can be used by stakeholders as an 'at-a-glance' summary of reported information and to identify particular themes or areas of interest.

Indicators can refer to one or more Principles. Some indicators are not specific to any Principle. These are highlighted in the 'General' column. When multiple Principles are covered across numerous indicators, in order to avoid repetition, only the main Principle covered is highlighted.

As a result of our commitment to Responsible Investing, we expect our sub-advisors to integrate material ESG factors into their investment analysis and decision-making processes as part of a holistic approach that aims to identify risks and opportunities that could have a pronounced effect on the long-term investment returns delivered to our clients. Concurrently, we expect our sub-advisors to be active owners through proxy voting and through engagement with both management and boards to improve ESG practices and enhance the disclosure of material ESG information by companies and stakeholders.

Our due diligence processes seek out sub-advisors whose investment processes require them to exercise professional judgment regarding material drivers of value. We encourage our sub-advisors to identify, monitor and mitigate ESG risks and opportunities that are, or could become material to long-term performance. We evaluate the ESG integration practices for new sub-advisors, and in the regular due diligence process for existing sub-advisors and promote the inclusion of ESG factors into their investment policies and processes where these are not employed today.

Active ownership is important in our funds. We encourage our sub-advisors to generally adopt a policy of engagement, including escalating measures of engagement, to enable us to contribute positively to a company's ESG progress. Selling an investment for ESG reasons alone is an option of last resort. Consistent with our responsibility, we ensure that our sub-advisors have an appropriate policy to vote proxies in the best interests of the Funds.

IG Wealth Management, together with its parent company, IGM Financial, supports the Task Force for Climate-Related Financial Disclosure (TCFD) recommendations which includes a recommendation for asset managers to disclose the process used to identify transition and physical climate-related risks and opportunities in investment strategies and products.

At a corporate level, climate-related risks are considered through our Enterprise Risk Management process and opportunities are considered through the annual business planning process. See further details about the climate-related risks and opportunities that we have identified in our annual CDP reporting for IGM Financial.

As a result of the TCFD recommendations and the broader implications for climate change on the world, we recognize the importance of enhancing processes to assess climate risks and opportunities for our investment funds. In 2019, we began to review tools that will enable us to quantify climate-related metrics in our investment funds. As a first step, in 2020 we plan to evaluate carbon footprint and intensity metrics to enhance investment processes and assess potential for use in climate disclosures. We believe that financial services companies have an important role to play in addressing climate change. As part of our responsible management philosophy, we proactively consider climate-related impacts on our business.

The identification and assessment of risks at a company level is coordinated through the Enterprise Risk Management Department who provide oversight, analysis and reporting on the level of risks relative to the established risk appetite of the Corporation.

Business leaders are responsible for identifying risks, ongoing risk assessments and mitigation plans within their respective departments, which are overseen by the Chief Executive Officers of the respective operating companies, and ultimately by the executive-led IGM Risk Management Committee who meet on a quarterly basis to review enterprise-wide risks.

Through our risk assessments, climate-related risks identified include issues such as: demand we are not able to meet for environmentally-focused investment products and services, credit risk and asset volatility from carbon-exposed investments, and exposure to weather-related events that could impact our investments, corporate properties, information technology systems and business continuity plans.

IG Wealth Management's parent company, IGM Financial, demonstrates its commitment to manage climate related risks and opportunities through a long-standing participation in the annual CDP survey. In 2019, IGM Financial and subsidiaries signed the TCFD statement of support, completed a gap analysis to the recommendations, and set up a working group to close the gaps and to move forward with implementation.

As part of our oversight and monitoring process of our sub-advisors we require them to complete questions as part of our Due Diligence Questionnaire (DDQ). We specifically ask them if there are any significant ESG related controversies at both the firm and mandate level. If there are significant controversies at the firm level, this would likely cause them to be placed on a watch-list and we would follow up with them on the specific incident or controversy. If we deemed the incident material enough we could ultimately replace the sub-advisor.

At the mandate level in addition to our own screening and looking for underlying holdings with controversies we do ask the sub-advisor if there are any holdings in the mandate that have ESG related controversies. We discuss specific cases during our regular due diligence meetings. We generally provide the portfolio manager with autonomy to determine how they will factor those ESG incidents into their investment analysis and decision making. This may be through additional research, company engagement and dialogue, voting against management on proxies, or divestment. Some controversies can also be a good buying opportunity if the company has been transparent, addresses the controversy, and made proactive steps to mitigate and avoid such events in the future.
