IGM FINANCIAL INC. ANNOUNCES JANUARY 2016 MUTUAL FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg – February 2, 2016: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total mutual fund net new money in January of (\$153.3) million as shown in Table 1. Total assets under management were \$131.0 billion at January 31, 2016, compared with \$133.6 billion at December 31, 2015 and \$145.5 billion at January 31, 2015. Mutual fund assets under management were \$124.9 billion as at January 31, 2016, compared with \$127.5 billion at December 31, 2015 and \$128.9 billion at January 31, 2015. Assets under management are shown in Table 2.
