IGM FINANCIAL INC. ANNOUNCES DECEMBER 2016 MUTUAL FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg – January 4, 2017: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total mutual fund net new money in December of \$112.6 million as shown in Table 1. Total assets under management were \$141.8 billion at December 31, 2016, compared with \$140.1 billion at November 30, 2016 and \$133.7 billion at December 31, 2015. Mutual fund assets under management were \$137.1 billion at December 31, 2016, compared with \$135.4 billion at November 30, 2016 and \$127.5 billion at December 31, 2015. Assets under management are shown in Table 2.
