



IGM FINANCIAL INC. ANNOUNCES APRIL 2019 INVESTMENT FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg – May 2, 2019: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total investment fund net new money of (\$274.4) million as shown in Table 1. Total assets under management were \$163.5 billion at April 30, 2019, compared with \$160.5 billion at March 31, 2019 and \$156.3 billion at April 30, 2018. Investment fund assets under management were \$157.4 billion at April 30, 2019, compared with \$154.3 billion at March 31, 2019 and \$149.7 billion at April 30, 2018. Assets under management are shown in Table 2.
