



IGM FINANCIAL INC. ANNOUNCES MAY 2019 INVESTMENT FUND SALES AND TOTAL ASSETS UNDER MANAGEMENT

Winnipeg – June 4, 2019: IGM Financial Inc. (IGM) (TSX: IGM) today reported preliminary total investment fund net new money of (\$82.2) million as shown in Table 1. Total assets under management were \$159.1 billion at May 31, 2019, compared with \$163.5 billion at April 30, 2019 and \$157.7 billion at May 31, 2018. Investment fund assets under management were \$153.2 billion at May 31, 2019, compared with \$157.4 billion at April 30, 2019 and \$151.1 billion at May 31, 2018. Assets under management are shown in Table 2.
